## What are Cookies

Cookies are small text files that the websites visited by the User send to their devices where they are memorized to be transmitted back to the same websites in case of subsequent visits by the User.

Cookies can be classified according to:

### Origin

– First-party Cookies: first-party Cookies are sent to the User's browser directly from this Website ;

– Third-party cookies: Third-party cookies belong to domains other than the one shown in the address bar.

### Lifecycle:

– Session cookies: Session cookies are automatically removed when the browser is closed and therefore have an expiration date;

– Persistent Cookies: Persistent Cookies have an expiration date and until this date or until they are manually deleted by the User through the "Delete browsing data" function of the browser used, they will send information to the server every time the User visits this Website.

### Purpose:

– Technical Cookies: Technical Cookies are used to allow the User to browse and facilitate the use of the services on this Website;

– Analytical Cookies: Cookies analytics are used to collect information in anonymous and aggregate form on the number of users and how they visit this Website;

– Profiling Cookies: Profiling Cookies are used to provide the User, through third party partners, with contents and commercial offers in line with your interests also based on your previous browsing experience on this Website.
